

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with U. S. Cost, Inc., to provide value engineering services for the South Subsystem of the Clean Water Program in conjunction with the services of Kramer, Chin & Mayo and Lewis & Zimmerman, under the terms and conditions set forth in the Agreement with U.S. Cost, Inc., on file in the office of the City Clerk as Document No. RR- 276988, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$58,552.00 from the Clean Water Program Fund (41509), CIP No. 45-910.3, Job Order No. 190128, is hereby authorized, solely and exclusively to provide funds for the above agreement.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance these activities with tax exempt securities, if circumstances so warrant.
