

that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with MARSH AND MCLENNAN, INC., to provide the City with a policy of Excess Public Liability Insurance for one-year period beginning December 15, 1990 through December 15, 1991, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 276390, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,726,714.00 (\$1,335,725.49 from Fund 100; \$234,593.11 from Fund No. 41506; and \$156,395.40 from Fund No. 41500), is hereby authorized, solely and exclusively for the



purpose of providing funds for the execution of the above agreement.
