WHEREAS, the Problem Oriented Policing (P.O.P.) Program is a step-by-step problem solving model that guides street level police officers in solving the underlying problems on service calls to specific locations; and

WHEREAS, the San Diego Police Department successfully field tested the P.O.P. Program during the period from November 1, 1989, through October 31, 1990, by contracting with Nancy McPherson, a consultant; and

WHEREAS, the San Diego Police Department recommends continuation of the P.O.P. Program department-wide; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with "Nancy McPherson," a consultant, for administrative and coordination services required for the implementation of the Police Department's Problem Oriented Police (P.O.P.) Program from November 1, 1990, through October 31, 1991, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 276991.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed fifty-eight thousand dollars (\$58,000.00) from Fund

No. 101321, Department No. 101321, Job Order No. 000001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
