BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, the fifth amendment to the agreement of September 27, 1988 with Regional Environmental Consultants (RECON), for additional environmental services, under the terms and conditions set forth in Amendment No. 5 on file in the office of the City Clerk as Document No. RR- 276392, together with any further modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and amendment.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$8,055,996.00 from CIP No. 46-155.0, State Ocean Plan Compliance, to CIP No. 46-147.0, Modified Wastewater Treatment Facilities Plan.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$521,386.00 from CIP 46-147.0, Modified Wastewater Treatment Facilities Plan, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
