BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$5,260.73 from Water Reserve Fund 41502, CIP No. 73-083, Annual Allocation - Water Main Replacements, is hereby authorized, solely and exclusively for the additional funding needed for the above Change Order No. 2.
