ADOPTED ON DEC 10 1990

WHEREAS, Art Lujan was recently appointed by Resolution No. R-276797 as a trustee of the San Diego Trust Fund Board of Directors to represent the Labor category; and

WHEREAS, it has since been determined that Mr. Lujan is not a resident of The City of San Diego as required by Council Policy 000-13; and


WHEREAS, Council Policy 000-13 does provide that the Council may make a conscious exception to the policy if the individual is a resident of the county, which is the case for Mr. Lujan; and

WHEREAS, the City Council did not declare such conscious exception and waiver and it is necessary to do so; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. R-276797, adopted October 30, 1990, appointing trustees of the Housing Trust Fund be and the same is hereby amended to express a conscious exception to Council Policy 000-13 for Mr. Art Lujan, non-city resident representing the Labor category on the Housing Trust Fund Board of Trustees, and declare a waiver of that policy requirement for Mr. Lujan.


