BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MISSION BEACH DRAINAGE PHASE 1 STREETS, ALLEYS AND DRAINS, San Diego, California, on file in the office of the City Clerk of San Diego, California, on DEC 10 1990, and bearing official Document No. W.O. 119256, be and the same are hereby approved.

2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MISSION BEACH DRAINAGE PHASE 1 STREETS, ALLEYS AND DRAINS.

4. That the expenditure, not to exceed \$4,340,000.00 from CIP No. 11-226.0 MISSION BEACH DRAINAGE, (\$2,738,000 CAPOUT Fund No. 30245; and \$1,602,000 from TRANSNET Fund No. 30300), is hereby authorized solely and exclusively for providing funds for

said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
