

RESOLUTION NUMBER R- 277024

ADOPTED ON DEC 10 1990

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING AT BERNARDO CENTER DRIVE FIRE STATION, filed in the office of the City Clerk of The City of San Diego, California, on DEC 10 1990, and bearing official Document No. W.O. 119632 be and the same are hereby approved.

2. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING AT BERNARDO CENTER DRIVE FIRE STATION.

4. That the City Auditor and Comptroller is hereby authorized to transfer \$9,310 from Fund No. 30300, CIP No. 68-008.0 ANNUAL ALLOCATION - TRAFFIC SIGNAL SUBSYSTEMS into Fund No. 302453, CIP No. 62-002.0 ANNUAL ALLOCATION MINOR TRAFFIC SIGNAL REQUIREMENTS.

5. That the expenditure, not to exceed \$44,310 from Fund No. 302453, CIP No. 62-002.0 ANNUAL ALLOCATION MINOR SIGNAL REQUIREMENTS, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in Fund No. 62-002.0.
