WHEREAS, Resolution No. R-276224, adopted July 30, 1990, authorized certain works to be done in respect to construction of San Pasqual Staging Areas; and

WHEREAS, the Council of The City of San Diego allocated sufficient funds for construction of trails, parking lot and other incidental costs; and

WHEREAS, the intent of the Council was to engage San Diego Conservation Corps ("SDCC") for purposes of clearing and constructing approximately 14 miles of hiking trails in San Pasqual Staging Areas; and

WHEREAS, The City of San Diego presently has an agreement with SDCC to provide personal services in projects such as this, and it is now deemed appropriate and desirable to authorize the City Manager to amend the contract with SDCC to provide for such services and compensation therefor; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to execute an amendment to the agreement between the City and SDCC, a copy of which is on file in the office of the City Clerk as Document No. RR- 277038 by amending Paragraph No. 5, Compensation, to change the total sum authorized therein provided by the Park and Recreation Department, from \$47,050 to \$241,650 to accommodate the additional tasks required by the City.

BE IT FURTHER RESOLVED, that the agreement with SDCC be further amended to reflect within the <u>Scope of Services</u> specific reference to construction of trails for open space in San Pasqual Staging Areas pursuant to Planning Department, Development and Engineering Planning Division Initial Study No. 90-0166, for a sum not to exceed \$194,600.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$194,600 from Environmental Growth Fund No. 10505, CIP No 20-010.7, Annual Allocation - Resource Based Open Space Parks, is hereby authorized, solely and exclusively for said project and related costs, and the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
