RESOLUTION NUMBER R-277050

ADOPTED ON DECEMBER 11, 1990

WHEREAS, on December 11, 1990, the Council for The City of San Diego considered the appeal of the San Diego Housing Partnership, by Michael B. Galasso, President of Metropolis Investment and Development, from the decision of the Historical Site Board in granting historic site designation of the Carnation/Qualitee Dairy Building, located at 354 Eleventh Avenue in San Diego, as Site No. 261, Grade 2; and

WHEREAS, in arriving at their decision the City Council considered the decision of the Historical Site Board, the staff report, materials presented prior to and at the public hearing and heard public testimony at the hearing; and

WHEREAS, the City Council found that the Carnation/Qualitee Dairy Building had historic and architectural significance and was a local landmark; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appeal of the San Diego Housing Partnership, by Michael B. Galasso, President of Metropolis Investment and Development, is denied and the decision of the Historical Site Board in designating the Carnation/Qualitee Dairy Building as Historical Site No. 261, Grade 2, is hereby upheld.


