BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Emergency Medical Services Training Institute (EMSTI) of the University of California, San Diego, Medical Center, for the paramedic training of City fire fighters, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277052 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$97,162.00, consisting of \$32,000.00 from Object Account 3105, \$7,162.00 from Object Account 3222, \$33,000.00 from Object Account 4103, and \$25,000.00 from Object Account 4212, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
