RESOLUTION NUMBER R- 277054

A RESOLUTION FORMALLY RECOGNIZING THE CITY HEIGHTS AREA PLANNING COMMITTEE AS A COMMUNITY PLANNING GROUP FOR A PORTION OF THE MID-CITY COMMUNITY PLANNING AREA.

WHEREAS, it is the policy of the City Council to require each community planning committee, as a condition of official recognition by The City of San Diego, to submit a copy of its own operating procedures and responsibilities, otherwise known as "bylaws," to the offices of the City Clerk and Planning Department; and

WHEREAS, Council Policy 600-24 requires that these bylaws must follow the format of its standard operating procedures and responsibilities and be in conformance with the criteria contained within. Additionally, each community planning committee and the initial members shall be approved by the Council; and

WHEREAS, a committee wishing to be recognized as the City Heights Area Planning Committee has submitted bylaws and initial membership to the City Clerk and the Planning Department; and

WHEREAS, it has been determined by the Planning Department and the City Attorney that these bylaws meet the requirements of Council Policy 600-24; and

WHEREAS, on October 3, 1990, the Rules and Legislative Committee voted 5-0 to approve these bylaws as recommended by the




