WHEREAS, on December 11, 1990, the Council of The City of San Diego considered the appeal of Alfred Strohlein from the decision of the Planning Director in approving an early release from Single-Family Neighborhood Protection Ordinance No. O-17250, Case No. 90-3024, submitted by Rudy Blevins, Applicant, for the property located at 1461 Chalcedony Street; and

WHEREAS, the property is located within the Pacific Beach Community Plan area and is more specifically described as Lots 16 and 17, Block 124, Pacific Beach Map 948, in the R-1500 zone; and

WHEREAS, the Planning Department recommended to release the subject property as the analysis of the neighborhood concluded that the area's character was multi-family; and

WHEREAS, the Pacific Beach Community Planning Committee on September 5, 1989, recommended approval for a neighborhood classification map which designates the property for multi-family development; and

WHEREAS, on August 8, 1990, after case review and public testimony, the Planning Director approved an early release request from the Single-Family Neighborhood Protection Ordinance; and

WHEREAS, subsequent to the decision of the Planning Director the City Clerk received several requests for appeal from the case decision from individuals in the area; and
