1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the IMPROVEMENT OF KING ELEMENTARY SCHOOL ATHLETIC FIELD, filed in the office of the City Clerk of The City of San Diego, California, on JAN 09 1991, and bearing official Document No. W.O. 118739 be and the same are hereby approved.

2. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the IMPROVEMENT OF KING ELEMENTARY SCHOOL ATHLETIC FIELD.

4. That the City Auditor and Comptroller is hereby authorized to transfer \$100,000.00 from Fund No. 79511, URBAN IMPACT FEES to CIP No. 29-470.0, MARTIN LUTHER KING ELEMENTARY SCHOOL TURFING, and authorizing the expenditure of \$391,250 from

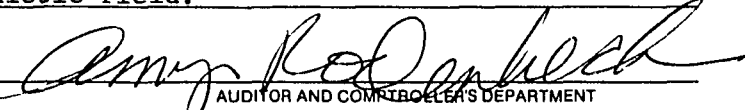
