BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF KEARNY MESA COMMUNITY PARK COMFORT STATION, San Diego, California, filed in the office of the City Clerk of San Diego, California, on JAN 09 1991, and bearing official Document No. W.O. 119335, be and the same are hereby approved.

2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF KEARNY MESA COMMUNITY PARK COMFORT STATION.

4. That the expenditure, not to exceed \$191,200.00 from CIP No. 29-679.0, KEARNY MESA COMMUNITY PARK REQUIREMENTS, PSD Fund No. 11430, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the
