WHEREAS, the issue was heard by the Council on June 4, 1991; and


WHEREAS, the Council of The City of San Diego considered the issues discussed in Negative Declaration No. 90-0872; NOW, THEREFORE,

BE IT FURTHER RESOLVED, that the Council finds, based upon the Initial Study and any comments received, that there is no

substantial evidence that the project will have a significant effect on the environment and therefore said Negative Declaration is hereby approved.
