WHEREAS, the San Diego Gulls Hockey franchise was established in 1990; and

WHEREAS, the San Diego Gulls Hockey Club set the all-time professional hockey record in 1993 for most victories in one season with 62; and

WHEREAS, the San Diego Gulls tied the all-time professional hockey record for most points in one season with 132; and

WHEREAS, the San Diego Gulls set International Hockey League records for victories and points in one season; and

WHEREAS, the San Diego Gulls set an all-time professional hockey record for most victories on the road in one season with 30; and

WHEREAS, the San Diego Gulls started the 1992-93 season with a record 25 game unbeaten streak, going 22-0-3, and finished the season with a remarkable record of 62-12-8; and

WHEREAS, the San Diego Gulls set or equalled 81 team records during the 1992-93 regular season; and

WHEREAS, the San Diego Gulls set attendance records by drawing over 300,000 fans to the San Diego Sports Arena and averaging nearly 8,000 fans per game; and

WHEREAS, the San Diego Gulls finished their third season and generated an unprecedented amount of national media coverage of hockey in America's Finest City; and

WHEREAS, the San Diego Gulls reached the Turner Cup finals, becoming the first professional team in San Diego to reach a championship in San Diego since the 1984 Padres; and

WHEREAS, the San Diego Gulls ownership, led by Fred and Bill Comrie, and aided by John Comrie and Bill Hunter, displayed a commitment to the City and its fans; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby congratulates the San Diego Gulls on their excellent season and commends them for their contributions to sports entertainment in San Diego.

BE IT FURTHER RESOLVED, that July 26, 1993 be and it is hereby proclaimed to be "SAN DIEGO GULLS DAY" in San Diego.
