AN ORDINANCE AMENDING CHAPTER I, ARTICLE 3,  
DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE  
BY AMENDING SECTIONS 13.0332 and 13.0342  
RELATING TO ADMINISTRATIVE REMEDIES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter I, Article 3, Division 3, of the San Diego Municipal Code be and the same is hereby amended by amending Sections 13.0332 and 13.0342, to read as follows:

§ 13.0332 DEFINITIONS

For purposes of Sections 13.0330 through 13.0338, the following definitions shall apply:

(a) The term "Director" shall include the Directors of the following Departments: Planning, Building Inspection, Engineering and Development, General Services, Animal Control, Health, Water Utilities, Waste Management, the Fire and Police Chiefs, and any of their designated agents or representatives.

(b) No changes to this subsection.

(c) No changes to this subsection.

§ 13.0342 DEFINITIONS

For purposes of Sections 13.0340 through 13.0348, the following definitions shall apply:

(a) The term "Director" shall include the Directors of the following Departments: Planning, Building Inspection, Engineering and Development, General Services, Animal Control, Health, Water Utilities, Waste Management, the Fire and Police Chiefs, and any of their designated agents or representatives.

(b) No changes to this subsection.


