AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2,  
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
SECTION 22.0209 RELATING TO ALTERATIONS IN  
CONTRACTS.

BE IT ORDAINED, by the Council of The City of San Diego, as  
follows:

Section 1. That Chapter 2, Article 2, of the San Diego  
Municipal Code be and the same is hereby amended by amending  
Section 22.0209 to read as follows:

**SEC. 22.0209 ALTERATIONS IN CONTRACTS**

Whenever it becomes necessary to make alterations in  
contracts entered into by the City, the City Manager shall  
make alterations only when authorized by the Council unless  
such alterations meet all of the following criteria:


(a) The cost of each alteration is less than \$100,000;

and

(b) through (d) [No change.]

Section 2. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage.
