AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.0226 RELATING TO THE HIRING OF CONSULTANTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, Division 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 22.0226, to read as follows:

§ 22.0226 Consultant Limitations

In connection with the provisions of Section 28 of the Charter of The City of San Diego, the City Manager, except as otherwise provided by Charter or ordinance, shall have the power to employ experts or consultants to perform work or give advice connected with departments of the City without first seeking Council approval under the following conditions:

1. All architectural or engineering consultants who are retained to design City Council approved individual capital improvement projects, in which the cost of such employment does not exceed Two Hundred Fifty Thousand Dollars (\$250,000.00), provided the cumulative dollar amount of the awards to that consultant during the fiscal year does not exceed Two Hundred Fifty Thousand Dollars (\$250,000.00).

2. All other consultants when the cost of each individual agreement for employment does not exceed Twenty-five Thousand Dollars (\$25,000.00), provided the cumulative dollar amount for these awards to that consultant during the fiscal year does not exceed One Hundred Thousand Dollars (\$100,000.00).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
