ADOPTED ON JAN 09 1991

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3,
DIVISION 6, OF THE SAN DIEGO MUNICIPAL CODE
BY AMENDING SECTION 103.0613 B.1.k AND ADDING
SECTION 103.0620 RELATING TO NORTH CITY WEST
PLANNED DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 3, Division 6, of the San Diego Municipal Code be and the same is hereby amended by revising Section 103.0613 B.1.k. to read as follows:

SEC. 103.0613 Special Use Area (SP)

A. [No change.]

B. DEVELOPMENT REGULATIONS

All paragraphs of Section 101.0410 R Zones (Multiple Family Residential) of the Municipal Code shall apply, with the exception of paragraph B. Permitted Uses. Instead, the following regulations shall apply:

1. Permitted Use

a. through j. [No change.]

k. Accessory uses customarily incidental to any of the foregoing permitted uses.

l. [No change.]

2. [No change.]

Section 2. That Chapter X, Article 3, Division 6, of the San Diego Municipal Code be and the same is hereby amended by adding Section 103.0620 to read as follows:

SEC. 103.0620 Permanent and Temporary Signage Guidelines

Notwithstanding any provision of the North City West Planned District Ordinance to the contrary, all signage located within the North City West Planned District area shall conform to the North City West Signage Guidelines and Criteria adopted by the City Council on JAN 09 1991, 1990, and filed in the office of the City Clerk as Document No. 00-17578. This document shall apply to all areas of the North City West Planned District. All other signage provisions contained within the North City West Planned District are superseded by the regulations set forth in this Section.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, however, the provisions of this ordinance shall not be applicable within the Coastal Zone until the thirtieth day following the date the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance shall be null and void within the Coastal Zone.

Section 4. In areas of the City of San Diego other than the Coastal Zone no permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.

Section 5. Within the Coastal Zone no permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date the California Coastal Commission unconditionally certified this ordinance as a local coastal program amendment.


