ORDINANCE NUMBER O-17581 (NEW SERIES)

ADOPTED ON JANUARY 10, 1991

AN ORDINANCE AMENDING ORDINANCE NO. O-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17504-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065) BY ADDING .17 SENIOR PLANNER, .17 CLERICAL ASSISTANT II, AND ONE (1.00) ASSOCIATE PLANNER POSITIONS TO PROGRAM ELEMENT 06532 FOR THE PURPOSE OF ADMINISTERING THE MISSION VALLEY PLANNED DISTRICT ORDINANCE; AUTHORIZING THE EXPENDITURE OF FISCAL YEAR 1991 FUNDS FROM SAVINGS DUE TO SUPPORT STAFF VACANCIES.

WHEREAS, modifications to the proposed Mission Valley Planned District ordinance were made after the adoption of the fiscal year 1991 appropriations ordinance; and

WHEREAS, the Mission Valley Planned District will require focused review and permit processing; and

WHEREAS, in addition, there are five adopted specific plans within the Mission Valley planning area that each require specialized review; and

WHEREAS, it is expected the area will generate approximately 20 ministerial permits, 10 discretionary permits and 120 plan checks annually; and

WHEREAS, approximately 61 percent of permit processing time is cost recoverable and, in addition, a Mission Valley Project Review Committee was established at the City Council meeting of June 12, 1990 which requires additional staff support; and

WHEREAS, the tasks associated with the administration of the planned district and specific plans will require approximately 3,260 hours annually, equivalent to 2.00 positions; and

WHEREAS, payment for said additional personnel can be accommodated by savings accrued in the department due to support staff vacancies; and

WHEREAS, it is now requested that the budget of the Planning Department be amended to add the personnel required to perform the additional tasks required by the Mission Valley Planned District ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by amending the personnel authorization of the Planning Department (065) by adding thereto .17 Senior Planner, .17 Clerical Assistant II, and 1.00 Associate Planner positions to Program Element 06532 for the purpose of administering the Mission Valley Planned District ordinance.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to expend funds for the additional positions from existing monies in the Planning Department due to staff support vacancies.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.


