BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17504-1 as amended and adopted therein, by amending the personnel authorization of the Community Services Program (058) by adding one (1.00) Disabled Services Coordinator position thereto.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$30,000 from the General Fund (100), Unallocated Reserve (605) to the Community Services

Program, Department 058; and \$10,000 from the General Fund (100),

Unallocated Reserve (605) to Non-departmental Expenses (601).

Section 3. That the Auditor and Comptroller be and he is hereby authorized to expend a sum not to exceed \$30,000 for salaries, fringe, and non-personnel expenses related to the Disabled Services Coordinator and \$10,000 for office modification and lease expenses.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
