AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0303 RELATING TO THE RECORDATION OF NONCONFORMING USES AND STRUCTURES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 3, of the San Diego Municipal Code be and the same is hereby amended by adding the following paragraphs to Section 101.0303 Section, to read as follows:

SEC. 101.0303 CONTINUANCE OF NONCONFORMING USES AND STRUCTURES

[Existing language of section unchanged.]

If an investigation by the Planning Department reveals that a particular property contains a legal, nonconforming use or structure, the Zoning Administrator may record a "Notice of Nonconforming Rights," in the County Recorder's office. This notice is designed to provide constructive notice to any successors in interest that nonconforming rights as to the property or structures existed at the time of the recordation of notice. Nothing in this notice shall permit the continuation of a nonconforming use or structure that was subsequently expanded, enlarged,

abandoned or destroyed which extinguishes the previous nonconforming right.

If a subsequent investigation reveals that a previous nonconforming right as to the property's use or structure has been lost, the Zoning Administrator shall record a cancellation of the Notice of Nonconforming Rights.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
