AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 1,
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 71.0130 RELATING TO THE
TRANSPORTATION DEMAND MANAGEMENT PROGRAM.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VII, Article 1, of the San Diego Municipal Code be and the same is hereby amended by amending Section 71.0130 to read as follows:

§ 71.0130 Transportation Demand Management Appeals Board

A. Creation and Membership

There is hereby created an Appeals Board which shall consist of seven members, who shall serve without compensation. The members shall be appointed by the Mayor and confirmed by the Council. The members shall serve three-year terms and each member shall serve until the member's successor is duly appointed and qualified. The members shall be appointed in such a manner that the terms of not more than three members shall expire in any year. The expiration date shall be May 1. The Board shall annually, on or after June 15, select from among its members a chairperson. The membership shall be balanced among affected businesses, property interests, and community representatives with


the majority of the membership representative of
business.
