AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH PACIFIC BELL FOR THE LEASE OF APPROXIMATELY 1,704 SQUARE FEET OF BLACK MOUNTAIN.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 20-year lease agreement, with one 10-year renewal option, with PACIFIC BELL, for approximately 1,704 square feet of land on Black Mountain, at a rental rate of \$6,000 per year, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. 00-17592.

Section 2. That the expenditure of an amount not to exceed \$2,500 from CIP 333950 for lease costs from February 1, 1991, to June 30, 1991, is hereby authorized and approved.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
