AN ORDINANCE AMENDING ORDINANCE NO. O-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17504-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE POLICE DEPARTMENT (110) BY ADDING TWO (2.00) RECORDS CLERKS POSITIONS TO THE RECORDS DIVISION; AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE GENERAL FUND 100 BY \$62,209 FOR THE PURPOSE OF FUNDING THE FINGERPRINT IDENTIFICATION SYSTEM (CAL-ID), TO BE ALLOCATED AS FOLLOWS: \$48,834 - PERSONNEL AND \$13,375 - NON-PERSONNEL; TO DEFRAY COSTS OF THE ADDITIONAL POSITIONS, SAID \$62,209 TO COME FROM REIMBURSEMENT FROM THE COUNTY OF SAN DIEGO SHERIFF'S DEPARTMENT AND BE DEPOSITED INITIALLY INTO GENERAL FUND 100 REVENUE ACCOUNT 79410 FOR THE ABOVE PURPOSE.

WHEREAS, Resolution R-269704, dated November 9, 1987, authorized the City to participate with the County and State in a Fingerprint Identification System called Cal-ID; and

WHEREAS, this system is a computer generated system that identifies suspects from fingerprints left at the scene of a crime and positively identifies arrestees at the time of booking; and

WHEREAS, locally, this program is administered by the San Diego County Sheriff's Department but authorization has been received from the Sheriff to reimburse the City for two Records Clerks to perform this function; and

WHEREAS, in order to accept this reimbursement it is necessary to amend the 1991 Appropriation Ordinance by adding two Records Clerks to the Records Division of the Police Department; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by amending the personnel authorization of the Police Department (110) by adding thereto two (2.00) Records Clerks to the Records Division of the Police Department (110) for the purpose of administering a Fingerprint Identification System.


Section 2. That the Auditor and Comptroller be and he is hereby authorized to increase the General Fund 100, Police Department (110) by \$62,209 for the above purpose, allocating said funds as follows: \$48,834 - personnel services and \$13,375 - non-personnel expenses to defray the costs associated with the positions added in section 1 above, said funds to come from reimbursements from the County of San Diego Sheriff's Department and to be deposited in the Revenue Account 79410, General Fund 100, to be expended for the purpose set forth above.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the
Charter of The City of San Diego.

This ordinance amends the annual appropriation ordinance by amending the personnel authorization of the Police Department (110) by adding two (2.00) Records Clerks in the Records Division. This ordinance also authorizes the Auditor and Comptroller to increase the General Fund 100 by \$82,209 to accommodate the personnel and nonpersonnel costs of these additional positions, said funds to come from reimbursement from the County of San Diego Sheriff's Department for the purpose of funding Fingerprint Identification System (CAL-ID) and expending monies thereon. 
