AN ORDINANCE AMENDING ORDINANCE NO. O-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17504-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE BUILDING INSPECTION DEPARTMENT (1300) BY ADDING .45 BUILDING INSPECTOR II POSITION FOR THE PURPOSE OF ADMINISTERING THE LOCAL MOBILEHOME PARK INSPECTION PROGRAM; AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE BUILDING INSPECTION ENTERPRISE FUND 41300 BY \$46,000 TO BE RECOVERED BY INCREASED MOBILEHOME PERMIT AND PARK FEES; AUTHORIZING THE AUDITOR AND COMPTROLLER TO ALLOCATE SAID \$46,000 TO THE BUILDING INSPECTION DEPARTMENT AS FOLLOWS: PERSONNEL EXPENSE - \$21,987, OVERHEAD - \$22,207 AND NONPERSONNEL EXPENSE - \$1,806.

WHEREAS, funding for the City's Mobilehome Park Inspection Program was not included in the fiscal year 1990-91 budget due to the program's inability to fully recover its costs; and

WHEREAS, as a result, the Building Inspection Department, at the July 30, 1990 City Council meeting, sought approval to formally notify the California State Department of Housing and Community Development of the City's intent to cancel our responsibility for the enforcement of the Mobilehome Parks Act and staff was also directed to seek an amendment to Legislative Bill AB 925 which related to mobilehome park permits and inspection fees; and

WHEREAS, successful efforts by the Department of Legislative Services resulted in the Governor signing AB 925 into law effective January 1, 1991, and it provides an additional \$4 per lot fee to be paid to the local enforcement agency exclusively for the inspection of mobilehome parks; and

WHEREAS, as a result, annual mobilehome park revenues are projected to total \$46,000 which would be available for the local mobilehome park inspection program; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by amending the personnel authorization of the Building Inspection Department (1300) by adding thereto .45 Building Inspector II position for the purpose of administering the Local Mobilehome Park Inspection Program.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to increase the Building Inspection Enterprise Fund 41300 by \$46,000 to be recovered by increased Mobilehome Permit and Park fees.

Section 3. That the Auditor and Comptroller be and he is hereby authorized to allocate said \$46,000 to the Building Inspection Department.



Section 4. That the following allocation of said funds is hereby approved in the Building Inspection Department: \$21,987 for personnel expenses, \$22,207 for overhead expenses, and \$1,806 for nonpersonnel expenses, to accommodate the above increase in personnel.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

AN ORDINANCE AMENDING ORDINANCE NO. 0-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17504-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE BUILDING INSPECTION DEPARTMENT (1300) BY ADDING 45 BUILDING INSPECTOR II POSITION FOR THE PURPOSE OF ADMINISTERING THE LOCAL MOBILEHOME PARK INSPECTION PROGRAM; AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE BUILDING INSPECTION ENTERPRISE FUND 41300 BY \$48,000 TO BE RECOVERED BY INCREASED MOBILEHOME PERMIT AND PARK FEES; AUTHORIZING THE AUDITOR AND COMPTROLLER TO ALLOCATE SAID \$48,000 TO THE BUILDING INSPECTION DEPARTMENT AS FOLLOWS: PERSONNEL EXPENSE - \$21,987. OVERHEAD - \$22,207 AND NONPERSONNEL EXPENSE - \$1,806.

This ordinance amends the annual appropriation ordinance by adding 45 Building Inspector II position to the Building Inspection Department for the purpose of administering the Local Mobilehome Park Inspection Program. This ordinance also increases the Building Inspection Enterprise Fund 41300 by \$48,000 to be recovered by increased Mobilehome Permit and Park fees and allocating said \$48,000 to the Building Inspection Department as follows: personnel expense - \$21,987, overhead - \$22,207 and nonpersonnel expense - \$1,806.


