AN ORDINANCE AMENDING CHAPTER EIGHT, ARTICLE SIX, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.01 RELATING TO PARKING METER NONENFORCEMENT DAYS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter Eight, Article Six, of the San Diego Municipal Code be and the same is hereby amended by amending Section 86.01, to read as follows:

SECTION 86.01 NONENFORCEMENT DAYS

The parking time restrictions imposed under or pursuant to the authority of this Article shall not apply on Sundays, New Year's Day, Martin Luther King, Jr.'s Birthday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day, and Christmas Day, upon the calendar dates on which these holidays are celebrated; provided, however, that the City Council may by resolution or ordinance, prohibit or limit parking on any street during all or certain hours of any such day and such limitation or prohibition shall be effective only when


