AN ORDINANCE SETTING ASIDE AND DEDICATING PARCEL 1 OF PARCEL MAP NO. 14743, BEING AN APPROXIMATELY 11.497-ACRE PARCEL LOCATED AT THE NORTHWEST CORNER OF NORTH CITY PARKWAY AND RANCHO CARMEL DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "CARMEL MOUNTAIN RANCH COMMUNITY PARK."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel 1 of Parcel Map No. 14743, being an approximately 11.497-acre parcel located at the northwest corner of North City Parkway and Rancho Carmel Drive, which is more particularly described in Exhibit 1 hereto which is by this reference incorporated herein, is hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Council of The City of San Diego hereby specifically reserves the right to establish underground public service easements through and across the dedicated property so long as the construction and maintenance of the subject easements do not substantially negatively impact the availability of the property for use for park and recreational purposes.

Section 3. That the hereinafter described real property be and the same is hereby named CARMEL MOUNTAIN RANCH COMMUNITY PARK.

Section 4. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
