ORDINANCE NUMBER O- 17617 / (NEW SERIES)

ADOPTED ON MAR 18 1991

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That various properties located near Brown Field, Montgomery Field, or NAS Miramar in the City of San Diego, California, that have been identified as being within the "60 Community Noise Equivalent Level" and/or within an "Accident Potential Zone" as shown on zone map drawings Nos. C-803, C-804, and C-805, filed in the office of the City Clerk as Document No.

00-17617, be, and they are hereby incorporated into the Airport Environs Overlay Zone, as such zone is described and defined by San Diego Municipal Code section 101.0444 to comply with the Comprehensive Land Use Plans as adopted by the Airport Land Use Commission and approved by the City Council.

Section 2. For that portion of the overlay zone not located within the Coastal Zone, this ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.

Section 3. For that portion of the overlay zone within the Coastal Zone this ordinance shall take effect and be in force on

the thirtieth day from and after the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment. No permits for development within the Coastal Zone inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date the California Coastal Commission unconditionally certified this ordinance as a local coastal program amendment.

Section 4. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance, with respect to the Coastal Zone, shall be null and void.
