BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 2. For that portion of the overlay zone not located within the Coastal Zone, this ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.

Section 3. For that portion of the overlay zone within the Coastal Zone this ordinance shall take effect and be in force on

the thirtieth day from and after the California Coastal

Commission unconditionally certifies this ordinance as a local

coastal program amendment. No permits for development within the

Coastal Zone inconsistent with the provisions of this ordinance

shall be issued unless application therefore was made prior to

the date the California Coastal Commission unconditionally

certified this ordinance as a local coastal program amendment.

Section 4. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance, with respect to the Coastal Zone, shall be null and void.
