AN ORDINANCE AMENDING ORDINANCE NO. O-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17504-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING ONE (1.00) PRINCIPAL PLANNER POSITION IN THE PLANNING DEPARTMENT (065) FROM THE CLASSIFIED SERVICE; AMENDING THE PERSONNEL AUTHORIZATION SCHEDULE OF THE PLANNING DEPARTMENT (065) TO REFLECT THE POSITION AS UNCLASSIFIED; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Planning Department has reorganized the
Environmental Analysis section of the Planning Department; and
WHEREAS, this reorganization will create a separate section
for Environmental Review of City CIP projects such as the Clean
Water Program and other public improvements; and

WHEREAS, the reorganization incorporates a change of classification of a Senior Planner position to Principal Planner; and

WHEREAS, this change will result in improved functional control of program activity as well as correct an existing overly broad span of control in the Environmental Analysis section; and

WHEREAS, this position has significant management level responsibilities; and

WHEREAS, the Planning Director requested the position of Principal Planner in the Environmental Analysis section be exempted from the classified service; and

WHEREAS, section 117(a)17 of the Charter provides that
"managerial employees having significant responsibilities for
formulating or administering departmental policies and programs"
may be exempted from the classified service by ordinance upon
first having been reviewed and commented upon by the Civil
Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on March 7, 1991 and has commented favorably (see attachment A) upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, this action will amend the appropriation ordinance to exempt the Principal Planner position from the classified service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on March 7, 1991, the Principal Planner in the Planning Department (065) be and it is hereby exempted from the classified service and declared to be in the unclassified service of The City of San Diego.

Section 2. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17504-1, as amended and adopted therein, by amending the personnel

authorization of the Planning Department (065) to reflect the exemption of the Principal Planner from the classified service and placement in the unclassified service.

Section 3. As a schedule of compensation for the above unclassified position recited in sections 1 and 2 hereof, funds appropriated and available therefor in the Planning Department the salary rate set forth in Salary Rates 7.7, 7.8, and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, contained in Exhibit C to Ordinance No. O-17468 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

On March 7, 1991, the Civil Service Commission reviewed a request from the Planning Department to review and comment on the exemption of a new Principal Planner position from the Classified Service.

Charter Section 117 states that the Unclassified Service shall include "Managerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council."

Upon review of the duties and responsibilities to be performed, the Commission finds that this position meets the criteria of the Charter and supports exemption from the Classified Service. If additional information would be of assistance in your consideration of this matter, staff is available to respond with details as necessary.
