

ORDINANCE NUMBER O- 17630 (NEW SERIES)

ADOPTED ON APR 16 1991

AN ORDINANCE AMENDING CHAPTER V, ARTICLE 9,
DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 59.0104 RELATING TO
ACTIVITIES PROHIBITED WITHIN THE SAN DIEGO
JACK MURPHY STADIUM PARKING FACILITY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 9, Division 1 of the San Diego Municipal Code be and the same is hereby amended by amending Section 59.0104 to read as follows:

SEC. 59.0104 Activities Prohibited within the San Diego Jack Murphy Stadium Parking Facility

(a) and (b) - NO CHANGE.

(c)(1) No person shall participate in any activity, including, but not limited to vehicle driver training, running, jogging, volleyball, baseball, soccer, football, roller skating, bicycle riding, skate boarding or frisbee within the San Diego Jack Murphy Stadium Parking Facility unless expressly authorized by the Stadium Manager.

(2) The fingerwalkways or promenades in the inner circle of San Diego Jack Murphy Stadium Parking Facility shall be restricted to pedestrian traffic. No tables, barbecues, chairs, umbrellas or other objects shall be permitted on such fingerwalkways or promenades without the written permission of the Stadium Manager.

(d), (e) and (f) - NO CHANGE.


(g) (1) - NO CHANGE.

(2) No person shall utilize in any manner more than the parking space or Tailgate Parking Space that his vehicle is entitled to occupy under the provisions of this Division. Turn areas in the inner ring of the Stadium Parking Lot shall remain clear of vehicles and objects to maximize turn area use for traffic circulation.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.






