ADOPTED ON APR 29 1991

AN ORDINANCE INCORPORATING VARIOUS PROPERTIES WITHIN THE MID-CITY COMMUNITY PLAN AREA (AREA D), IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM R1-40000/HR INTO R1-40000 ZONE, AS DESCRIBED AND DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407, AND REPEALING ORDINANCE NO. O-16993 (NEW SERIES), ADOPTED DECEMBER 7, 1987, IN THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That the property, located between 37th Street and 38th Street south of Wightman Street and north of Landis Street located within Area D of the Mid-City Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R1-40000/HR" on Zone Map Drawing No. B-3919.1, filed in the office of the City Clerk as Document No. OO-17636, be, and it is hereby incorporated into the R1-40000 zone, as such zone is described and defined by San Diego Municipal Code Section 101.0407.

Section 2. That Ordinance No. O-16993 (New Series), adopted December 7, 1987, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
