AN ORDINANCE REZONING VARIOUS PROPERTIES LOCATED WITHIN THE MIRAMAR RANCH NORTH COMMUNITY PLAN AREA, INCORPORATING PARCEL 1 AND PARCEL 2, OF PARCEL MAP NO. 11571, PARCEL 2 OF PARCEL MAP NO. 11428, PARCEL 1 OF PARCEL MAP NO. 11698, LAGO DORADO INDUSTRIAL PARK PER MAP NO. 11991, PORTION OF THE SOUTHWEST QUARTER OF SECTION 28, PORTION OF THE NORTHWEST QUARTER OF SECTION 33, AND PORTION OF THE NORTHWEST QUARTER OF SECTION 32, SECTION 27, TOWNSHIP 14 SOUTH, RANGE 2 WEST, SAN BERNARDINO MERIDIAN, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM M-LI INTO R1-5000, R1-6000, R1-8000 AND R-1500 ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0404, 101.0407 AND 101.0410 AND REPEALING ORDINANCE NO. 9986 (NEW SERIES), ADOPTED MARCH 13, 1969, ORDINANCE NO. 10205 (NEW SERIES), ADOPTED DECEMBER 18, 1969, ORDINANCE NO. 10261 (NEW SERIES), ADOPTED APRIL 7, 1970, ORDINANCE NO. 11427 (NEW SERIES) ADOPTED NOVEMBER 7, 1974 AND ORDINANCE NO. 16579 (NEW SERIES) ADOPTED JANUARY 21, 1986 OF THE ORDINANCES OF THE CITY OF SAN DIEGO AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

A. . . .

Section 1. That in the event that within three years of the effective date of this ordinance incorporating Parcel 1 and Parcel 2, of Parcel Map No. 11571, Parcel 2 of Parcel Map No. 11428, Parcel 1 of Parcel Map No. 11698, Lago Dorado Industrial Park per Map No. 11991, portion of the Southwest Quarter of Section 28, portion of the Northwest Quarter of Section 33, and portion of the Northwest Quarter of Section 32,

Section 27, Township 14 South, Range 2 West, San Bernardino Meridian, in the Miramar Ranch North Community Plan area, in The City of San Diego, California, designated R1-5000, R1-6000, R1-8000 and R-1500 zones, on Zone Map Drawing No. C-838 is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code sections 101.0404, 101.0407 and 101.0410 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into R1-5000, R1-6000, R1-8000 and R-1500 zones, as described and defined by Sections 101.0404, 101.0407 and 101.0410, the boundary of such zone to be as indicated on Zone Map Drawing No. C-838 filed in the office of the City Clerk as Document No.00-17637. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 9986 (New Series), adopted March 13, 1969, Ordinance No. 10205 (New Series), adopted December 18, 1969, Ordinance No. 10261 (New Series) adopted April 7, 1970, Ordinance No. 11427 (New Series), adopted November 7, 1974, and Ordinance No. 16579 (New Series), adopted January 21, 1986, be, and the same are hereby repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
