AN ORDINANCE REZONING VARIOUS PROPERTIES GENERALLY LOCATED SOUTH OF HIGHWAY 905, BETWEEN HOLLISTER STREET AND THE EASTERN BOUNDARY OF THE SAN YSIDRO COMMUNITY PLAN AREA MORE SPECIFICALLY IDENTIFIED ON MAP C-836.1, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR THE PURPOSE OF IMPLEMENTING THE 1990 UPDATE OF THE SAN YSIDRO COMMUNITY PLAN, AND REPEALING REZONING ORDINANCES OF THE CITY OF SAN DIEGO ADOPTED PREVIOUSLY INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the properties located within the San Ysidro Community Plan Area in the City of San Diego, California, as designated on Zone Map Drawing No. C-836.1, filed in the office of the City Clerk as Document No. 00-17641, are hereby rezoned from various City-wide zones to City-wide residential zones as such zones are described and defined by the San Diego Municipal Code, Chapter X, Article 1, Divisions 4, 7 and 8 and to the San Ysidro zone CSR-3 and the Community Plan Implementation Overlay Zone (CPIOZ).

Section 2. That the following ordinances of The City of San Diego be repealed insofar as they conflict with provisions of this ordinance:

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, however, the provisions of this ordinance shall not be applicable within the Coastal Zone until the thirtieth day following the date the California Coastal Commission unconditionally certifies this ordinance as a local coastal program amendment. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance shall be null and void within the Coastal Zone.

Section 4. In areas of the City of San Diego other than the Coastal Zone no permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was submitted prior to the effective date of this ordinance.

Section 5. Within the Coastal Zone no permits for development inconsistent with the provisions of this ordinance shall be issued after this ordinance becomes effective in the Coastal Zone.

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3, DIVI-SION, 22; OF THE SAN DEGO MUNICIPAL CODE BY AMEN-DING SECTION 103,2202, 103,2203, 103,2204 AND 103,2206 RELATING TO, THE SAN YSIDRO IMPLEMENTING ORDI-MANCE.

This ordinance amends the San Yaldro Implementing Ordinance by amending paragraph B.1. of Municipal Code section 103.2203 to delete the provision providing for ministerial review of applications for projects of one dwelling unit per lot. Paragraph D.1.e. of Municipal Code section 103.2203 which requires a clarationary permit for development of four or more dwelling units is amended by deleting this requirement and paragraph D.2. is amended by deleting a reference to Planned Residential Development Permits (Municipal Code section 101.0901). Municipal Code section 103.2204, paragraph A, is amended to Identify the map drawing numbers which portray the areas included within the commercial zones of San Yeldro.
