AN ORDINANCE AMENDING ORDINANCE NO. 0-17504 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17504-1, AS AMENDED AND ADOPTED THEREIN, BY DIRECTING THE AUDITOR AND COMPTROLLER TO INCREASE GENERAL FUND 100 APPROPRIATIONS BY \$83,687 TO COME FROM REIMBURSABLE PROJECTS AND INCREASING THE SUPPLIES AND SERVICES AUTHORIZATION OF THE PROPERTY DEPARTMENT (07000) BY THE SAME AMOUNT; DIRECTING THE AUDITOR AND COMPTROLLER TO SUBSTITUTE APPROPRIATIONS FUNDED BY THE FEDERAL REVENUE SHARING FUND (18014) IN THE CURRENT OR FUTURE YEARS WITH GENERAL FUND (100) REVENUE IN AN EQUAL AMOUNT; BY DIRECTING THE AUDITOR AND COMPTROLLER TO APPROPRIATE AND TRANSFER MONIES IN THE TRANSIENT OCCUPANCY TAX UNAPPROPRIATED RESERVE FUND (10224) IN ACCORDANCE WITH THE SAN DIEGO HOUSING TRUST ORDINANCE NO. 0-17455 AND MUNICIPAL CODE SECTION 35.0128A(c); BY DIRECTING THE AUDITOR AND COMPTROLLER TO REIMBURSE ALL CONTRIBUTIONS AND INTEREST EARNINGS FROM THE CITY-SPONSORED GROUP HEALTH INSURANCE FOR ELIGIBLE RETIREES FUND 60017 TO THE VARIOUS CONTRIBUTING FUNDS AND DEPARTMENTS; BY DIRECTING THE AUDITOR AND COMPTROLLER TO INCREASE APPROPRIATIONS TO THE TRANSIENT OCCUPANCY TAX FUND 10223 BY \$165,000 AND AMENDING THE AUTHORIZATION TO THE CONVENTION AND PERFORMING ARTS CENTER (PROGRAM 91503) BY THE SAME AMOUNT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17504 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1990-91 AND APPROPRIATING THE NECESSARY MONEY TO

OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17504-1, and adopted and amended therein by increasing the General Fund 100 appropriation and the supplies and services appropriation of the Property Department (07000) by the sum of \$83,687, said sum to come from reimbursable projects revenue.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to substitute appropriations funded by the Federal Revenue Sharing Fund (18014) in the current or future years with General Fund (100) Revenue in an equal amount and appropriate any current or future fiscal year Revenue Sharing Fund (18014) savings from completed Capital Projects, for the purpose of reimbursing the General Fund (100) for expenses of the Police Department (110) DARE Program; and he is further directed to appropriate in the General Fund (100) Allocated Reserve (Department 901), with unanticipated reimbursement revenues to the General Fund the sums of \$35,000 for the Santee-San Diego Mast Reorganization Cooperation Agreement and \$21,497 for the Federal Lawsuit, entitled Chicano Federation of San Diego County, et al. v. City of San Diego et al., Case No. 88-013-R(M).

Section 3. That the Auditor and Comptroller be and he is hereby authorized to appropriate funds in the Transient Occupancy Tax Unappropriated Reserve Fund (10224) and transfer said funds to the San Diego Housing Commission for use in accordance with the San Diego Housing Trust Ordinance No. 17455 and Municipal Code section 35.0128A(c).

Section 4. That the Auditor and Comptroller be and he is hereby authorized to reimburse all contributions and interest earnings from the City-Sponsored Group Health Insurance for Eligible Retirees Fund 60017 to the various contributing funds and departments.

Section 5. That the Auditor and Comptroller be and he is hereby authorized to increase the total Transient Occupancy Tax Fund 10223 appropriations and the appropriation of the Convention and Performing Arts Center (Program 91503) by the sum of \$165,000.

Section 6. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17, and 71 of the Charter of The City of San Diego.

THROUGH 5.; AMENDING APPENDIX F OF CHAPTER X, ARTICLE 3, DIVISION 12; AND AMENDING APPENDIX A OF CHAPTER X, ARTICLE 3, DIVISION 21; ALL RELATING TO CHILD CARE FACILITIES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 1, of the San Diego Municipal Code be and the same is hereby amended by adding Sections 101.0101.0101, 101.0101.0102, 101.0101.0103 and 101.0101.0104, to read as follows:

## SEC. 101.0101.0101 CHILD CARE FACILITIES

"Child care facilities" means those facilities that provide non-medical care to seven (7) or more children under eighteen (18) years of age in need of
