

ORDINANCE NUMBER O-17674 (NEW SERIES)

ADOPTED ON SEPTEMBER 9, 1991

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING A NEW DIVISION 10, SECTIONS 26.1001 AND 26.1002, ESTABLISHING A WETLANDS ADVISORY BOARD TO ADVISE THE MAYOR, CITY COUNCIL AND CITY MANAGER ON PUBLIC POLICY MATTERS RELATING TO WETLANDS IN THE CITY OF SAN DIEGO AND ESTABLISHING MEMBERSHIP CRITERIA FOR MEMBERS OF THE BOARD.

WHEREAS, the Park and Recreation Board recommended that the City Council establish a Wetlands Advisory Board to advise the Mayor, City Council and City Manager on conservation of wetlands City-wide; and

WHEREAS, since many wetlands are part of City parks, it is important that there be a park and recreation perspective on the Wetlands Advisory Board; and

WHEREAS, while it is recommended that a member appointed by the Chair of the Park and Recreation Board serve on the Wetlands Advisory Board, all appointments will be made by the Mayor, subject to confirmation by the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 6, of the San Diego Municipal Code be and the same is hereby amended by adding Division 10, entitled "Wetlands Advisory Board" to read, as follows:

**SEC. 26.1001 PURPOSE AND INTENT**

It is the purpose and intent of the City Council to establish a Wetlands Advisory Board, pursuant to section 43(a) of the City Charter to serve as an advisory body to the Mayor, City Council and City Manager on public policy matters relating to wetlands in The City of San Diego.

It is further the purpose and intent of the City Council to make available to City government the talents of those involved in various disciplines including, but not limited to, representation from the following organizations and/or interests: wetland specialist, environmental groups, land use planners, and community at large.

It is intended that all Board decisions for any recommended action be presented to the City Council and that those issues which go directly to City Council shall continue to do so and not be directed or addressed preliminarily to Council Committees unless so directed by the City Council.

**SEC. 26.1002 WETLANDS ADVISORY BOARD ESTABLISHED**

**A. ESTABLISHMENT**

There is hereby established a Wetlands Advisory Board consisting of fifteen (15) members, who shall serve without compensation. The members shall be appointed by the Mayor and confirmed by the Council. All members of the Board shall be residents of The City of San Diego unless otherwise waived by the Council pursuant to Council Policy 000-13.

**B. MEMBERSHIP AND FIELDS OF EXPERTISE**

Fifteen environmental advocates, as follows:

1. Three (3) Wetland Scientists: degree in wetlands ecology or closely related field and two (2) years of experience;
2. One (1) Environmental Education/ Outreach person: degree or two years experience in environmental education;
3. One (1) Fundraiser: four (4) years experience in fundraising;
4. One (1) Land Use expert: degree in land use planning or closely related field and two (2) years experience in environmental land use planning and regulations;

5. One (1) representative from Park and Recreation Board: nominated by Chair of the Park and Recreation Board to represent them and provide coordination;

6. Four (4) citizen members representing the following wetland types: vernal pools, coastal salt marsh, riparian fresh water habitat and marine resources; with consideration given to geographic diversity;

7. Three (3) representatives from broad based Environmental Organizations; and

8. One (1) member representing landowners.

Committee membership may be adjusted by City Council as needed to meet changing requirements.

**C. TERMS OF MEMBERS AND RULES**

The members shall serve two-year terms and each member shall serve until a successor is duly appointed and confirmed. The members shall be appointed in such a manner so that the terms of not more than eight (8) members shall expire in any year. The expiration date of all terms shall be July 1. During July of each year, the Mayor may designate one (1) member as Chairperson; however, in the absence of such designation, the Board

shall, on or after August 15, select a  
Chairperson from among its members. Any  
vacancy shall be filled for the unexpired  
term of the member whose place becomes  
vacant. The Board shall adopt rules  
consistent with the law for the government of  
its business and procedures.

Section 2. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage.

This ordinance creates a Wetlands Advisory Board comprised of fifteen  
(15) members to be appointed by the Mayor and confirmed by the Council.  
Terms shall be two years and members shall represent various organiza-  
tions and/or interests. The Board shall advise the Mayor, Council and City  
Manager on public policy matters relating to wetlands in The City of San  
Diego.


