ORDINANCE NUMBER O- 17679 (NEW SERIES)

ADOPTED ON SEP 09 1991

AN ORDINANCE INCORPORATING LOTS 8 THROUGH 18 OF WATERIDGE I, FINAL MAP NO. 10602, APN NO. 341-352-2 THROUGH 12, LOCATED ON WATERIDGE VISTA DRIVE AND WATERIDGE CIRCLE, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM M-IP INTO CA ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0428, AND AMENDING ORDINANCE NO. O-15291 (NEW SERIES), ADOPTED JULY 14, 1980, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 8 through 18 of Wateridge I, Final Map No. 10602, located on Wateridge Vista Drive and Wateridge Circle, in the Mira Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-IP" on Zone Map Drawing No. B-3975,¹ filed in the office of the City Clerk as Document No. 00-17679, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by San Diego Municipal Code section 101.0428.


Section 2. That Ordinance No. O-15291 (New Series), adopted July 14, 1980, of the ordinances of The City of San Diego be and it is amended for the lots being rezoned described in Section 1 of this ordinance insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after the date the California Coastal Commission unconditionally certifies this ordinance as a

local coastal program amendment. If this ordinance is not certified, or is certified with suggested modifications by the California Coastal Commission, the provisions of this ordinance shall be null and void.

Section 4. No permits for development inconsistent with the provisions of this ordinance shall be issued after the date on which this ordinance becomes effective within the Coastal Zone, as specified in Section 3 of this ordinance.
