ORDINANCE NUMBER O- 17680 (NEW SERIES)

ADOPTED ON SEP 09 1991

AN ORDINANCE INCORPORATING 4424 56TH STREET LOCATED IN THE MID-CITY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM MR-1000 INTO THE R1-5000 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407, AND REPEALING ORDINANCE NO. O-16577 (NEW SERIES), ADOPTED JANUARY 21, 1986 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That the property located at 4424 56th Street, in the Mid-City Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R1-5000" on Zone Map Drawing No. B-3980, filed in the office of the City Clerk as Document No. 00-17680, be, and it is hereby incorporated into R1-5000 Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0407.

Section 2. That Ordinance No. 16577 (New Series), adopted January 21, 1986, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building

permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
