for any increase in the cost of energy
purchased by the City. Notice of such
increase in sewer rates shall be given by the
City Manager to the City Council by report
and to the public by publication once in the
City Official Newspaper on or before the
thirtieth (30th) day prior to the effective
date of such increase.

Section 2. That Chapter VI, Article 7, of the San Diego Municipal Code be and the same is hereby amended by amending Section 67.59.1 to read as follows:

### SECTION 67.59.1 WATER RATES - ADJUSTMENTS

The water rates established in this

Article shall be adjusted as necessary by the
City Manager to compensate proportionately
for any increase in the cost of water and
energy purchased by the City. Notice of such
increase in water rates shall be given by the
City Manager to the City Council by report
and to the public by publication once in the
City Official Newspaper on or before the
thirtieth (30th) day prior to the effective
date of such increase.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
