ORDINANCE NUMBER O- 17700 (NEW SERIES)

ADOPTED ON 0CT 071991

WHEREAS, The City of San Diego has joint use agreements with the San Diego Unified School District for use of tennis courts at several high schools, which have been in effect since July 1977; and

WHEREAS, there is a general need for more tennis facilities in the beach and Clairemont areas, since interest in tennis is increasing, and these communities are growing in population; and

WHEREAS, this action will establish a joint use agreement for a period of twenty-five (25) years for use of the tennis courts at Mission Bay Senior High School; and

WHEREAS, the District will use the courts during hours of school operation and will provide daily maintenance of courts during those days when school is in session, and the City will have use of the courts after school hours and on weekends; and

WHEREAS, the City will assume responsibility for resurfacing the courts, providing nets and windscreens, and the Mission Beach Tennis Club, which will operate and maintain the courts at no cost to the City, will provide such maintenance; NOW THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute a twenty-five (25) year agreement with the San Diego Unified School District for maintenance and operation of tennis courts at the Mission Bay Senior High School site, effective September 2, 1991,

under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. 00- 17700, together with any reasonably necessary modifications or amendments thereto which do not increase the agreement's scope or cost and which the City Manager may deem necessary from time to time in order to carry out the purposes and intent of this agreement.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
