BE IT ORDAINED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute a fifteen (15) year agreement with the San Diego Community College District for joint use of City and District facilities, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. OO- 17709, together with any reasonably necessary modifications or amendments thereto which do not increase the agreement's scope or cost and which the City Manager may deem necessary from time to time in order to carry out the purposes and intent of this agreement.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
