AN ORDINANCE AMENDING ORDINANCE NO. O-17667 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1991-92 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17667, AS AMENDED AND ADOPTED THEREIN, BY ADDING \$150,000 TO THE GENERAL FUND, NONDEPARTMENTAL EXPENDITURES ANNUAL AUDIT PROGRAM TO BE REIMBURSED BY THE SAN DIEGO DATA PROCESSING CORPORATION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17667 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1991-92 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17667, as amended and adopted therein, by adding \$150,000 to the General Fund, Nondepartmental Expenditures Annual Audit Program, to be reimbursed by the San Diego Data Processing Corporation.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
