AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, SECTION 22.0101 OF THE SAN DIEGO MUNICIPAL CODE PROVIDING FOR THE PERMANENT RULES OF THE CITY COUNCIL BY AMENDING RULE 3 RELATING TO PROCEDURE FOR COUNCIL MEETINGS AND RULE 8 RELATING TO PUBLIC COMMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, of the San Diego Municipal Code be amended by amending Section 22.0101, Rule 3, entitled "PROCEDURE FOR COUNCIL" by placing the order of Public Comment after the Invocation and Pledge of Allegiance and before Special Order of Business on Monday, and after Roll Call and before Requests for Continuance on Tuesday, to read as follows:

RULE 3. PROCEDURE FOR COUNCIL MEETINGS

The order of business for Council meetings shall be as follows:

Monday Meeting at 2:00 p.m.

1. Roll Call
2. Invocation and Pledge of Allegiance
3. Public Comment (limited to three (3) minutes - see Rule 8)
4. Special Orders of Business
5. Requests for Continuances
6. Communications (See Rule 5)

7. Adoption Agenda
 - (a) Consent Items
 - (b) Committee Items
 - (c) Other Legislative Items
8. Public Notices
9. Non-docket items under Rule 30
10. Adjournment

Tuesday Meeting at 9:00 a.m.

1. Roll Call
2. Public Comment (limited to three (3) minutes - See Rule 8)
3. Requests for Continuance
4. Adoption Agenda
 - (a) Noticed Hearings (to be scheduled at various times throughout the day by the City Clerk based on the number of hearings and reasonable expectation of length) and Special Hearings.
 - (b) Unfinished Business from Monday Meeting.
5. Non-docket items under Rule 30
6. Adjournment

Section 2. That Section 22.0101, Rule 8, entitled "Public Comment" be and the same is hereby amended to limit public comment to three (3) minutes per subject, regardless of the number of people in attendance, to read as follows:

RULE 8. PUBLIC COMMENT

No change in subsections a. and b.

c. Speakers shall be limited to three (3) minutes each and comments shall be limited to three (3) minutes per subject regardless of the number of people in attendance. Anyone desiring to speak shall reserve time at the meeting by filing a written request with the Clerk. Speakers will be called in the order reserved within the available time.

No change in subsections d. through e.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
