AN ORDINANCE AMENDING CHAPTER V, ARTICLE 5, DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 55.0310.0301 RELATING TO FIRE PROTECTION AND PREVENTION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 5, of the San Diego Municipal Code be and the same is hereby amended by amending section 55.0310.0301, as follows:

## SEC. 55.0310.0301 INSTALLATION

U.F.C. 10.301 (1988 edition) is adopted and amended to read as follow:

No changes in (a) through (f).

(g) Installation of Fire Sprinklers in Existing High-Rise Buildings.

No changes in subsections (1) through (4).

(5) No changes in the first six paragraphs of this subsection.

Notwithstanding the above, the owner of any high-rise building or structure that is subject to the provisions of this subsection and that contains significant quantities of asbestos, who agrees in writing prior to January 1, 1996, to demolish the subject building, shall be exempt from this compliance schedule.

The written agreement provisions shall constitute a covenant running with the land. Such agreement shall be recorded in the office of the office of the County Recorder, San Diego County.

The recordable agreement form (demolition agreement) shall be provided by the City.

- (6) through (7) No changes.
- (8) Violations no changes in the first paragraph.

It shall be unlawful for the owner of any high-rise building or structure that is exempt from the compliance schedule set out in subsection (g)(5), to allow any person to occupy the building or structure after January 1, 2000, if the building or structure has not been demolished pursuant to that exemption, other than construction or maintenance workers involved in minimal maintenance to prevent the building or structure from being in an unsafe condition or involved in the installation of an approved automatic fire sprinkler system. Any minimal maintenance work shall be approved in advance and in writing by the City Manager or his authorized representative. The highrise building or structure shall not be occupied until an approved fire sprinkler system has been completely installed.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Owner(s) who fail to comply with written agreement shall not occupy high-rise building or structure.
