RESOLUTION NUMBER R- 277086

APPROVING MAP OF SCRIPPS RANCH  
NORTH UNIT NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "SCRIPPS RANCH NORTH UNIT NO. 2 being a subdivision of a portion of the south half of the southwest quarter of Section 21, a portion of the south half of the southeast quarter of Section 20, a portion of the northeast quarter of Section 29, Township 14 South, Range 2 West, San Bernardino Meridian, according to official plat thereof, and a portion of Parcel 1 of Parcel Map No. 14987, according to map thereof filed in the office of the County Recorder of San Diego County, September 24, 1987, all in the City of San Diego, County of San Diego, State of California, together with Spring Canyon Road as dedicated to public use" is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Scripps Summit Drive and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on the map within the subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across Lots "B", "C", and "D", as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the open space easement over, upon or across all of Lot "A", as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the landscape easements over, upon or across Lots "B", "C", and "D", and a portion of Lot 6, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts of behalf of The City of San Diego, any and all right to construct, erect or maintain any structure upon or across those portions of Lots 1, 2, 3 and 5, as shown on this map within this subdivision and designated "Building Rights Relinquished Hereon," as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street is accepted on behalf of the public as heretofore stated; together with the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as well as the building restricted, open space and landscape easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map through an escrow with First American Title Insurance Company, as more fully described below, to the County Recorder of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Council does hereby ratify the terms and conditions of the Escrow Agreement between The City of San Diego, McMillin-BCED/Miramar Ranch North, American Insurance Company, and First American Title Insurance Company, a copy of which is on file in the office of the City Clerk as Document No. RR- 277104 .
