APPROVING MAP OF SCRIPPS RANCH  
NORTH UNIT NO. 4.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "SCRIPPS RANCH NORTH UNIT NO. 4 being a subdivision of a portion of Parcel 1 of Parcel Map No. 14987, according to map thereof filed in the office of the County Recorder of San Diego County, September 24, 1987, together with a portion of the east half of Section 29, Township 14 South, Range 2 West, San Bernardino Meridian, according to official plat thereof, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: North Brookville Drive, South Brookville Drive, Wincheck Road, Atwood Court, Hall Meadow Road, Ramsdell Court, Lindly Court, Albury Court, and Pickford Road, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on

behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the map within the subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across all of Lot "A", as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the open space easements over, upon or across all those portions of Lots 119 and 121, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the landscape easements over, upon or across all of Lot "A", and that portion of Lot 119, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts of behalf of The City of San Diego, any and all right to construct, erect or maintain any structure upon or across those portions of Lots 2 through 15 inclusive, 19 through 27 inclusive, and 121, as shown on this map within this subdivision and designated "Building Rights Relinquished Hereon," as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and

for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as well as the building restricted, open space and landscape easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map through an escrow with First American Title Insurance Company, as more fully described below, to the County Recorder of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Council does hereby ratify the terms and conditions of the Escrow Agreement between The City of San Diego, McMillin-BCED/Miramar Ranch North, American Insurance Company, and First American Title Insurance Company, a copy of which is on file in the office of the City Clerk as Document No. RR- 277104.
