RESOLUTIONS OF THE COUNCIL OF THE CITY OF SAN
DIEGO, CALIFORNIA, DECLARING THE RESULTS OF A
"MELLO-ROOS COMMUNITY FACILITIES ACT OF 1982"
SPECIAL TAX AND BOND AUTHORIZATION ELECTION.

(Community Facilities District No. 1 [Miramar Ranch North])

WHEREAS, the City Council of The City of San Diego,
California (hereinafter referred to as the "legislative body of
the local Agency") has previously declared its intention and held
and conducted proceedings relating to the issuance of bonds to be
secured by special taxes to pay for certain public capital
facilities in a Community Facilities District, as authorized
pursuant to the terms and provisions of the "Mello-Roos Community
Facilities Act of 1982," being Chapter 2.5, Part 1, Division 2,
Title 5 of the Government Code of the State of California, said
Community Facilities District being referred to as Community
Facilities District No. 1 [Miramar Ranch North] (hereinafter
referred to as the "District"); and

WHEREAS, said legislative body did call for and order to be
held an election to submit to the qualified voters of the
District a proposition to incur a bonded indebtedness secured by
a special tax levy to pay for certain capital facilities in the
District; and

WHEREAS, at this time said election has been held and the
measure voted upon, and this legislative body does desire to
declare the results of the election in accordance with the


provisions of the Elections Code of the State of California; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as
follows:

1. That the above recitals are all true and correct.
2. That the legislative body hereby receives and approves
the Certificate of Election Official and Statement of Votes Cast,
as submitted by the City Clerk of the City, said Statement
setting forth the number of votes cast in the election, the
measure voted upon, and the number of votes given for and/or
against the measure voted upon. A copy of said Certificate and
Statement is attached hereto, marked Exhibit "A," referenced and
so incorporated.
3. That the City Clerk is hereby directed, pursuant to the
provisions of the Elections Code of the State of California, to
enter in the minutes the results of the election as set forth in
said Statement of Votes Cast.

I, CHARLES G. ABDELNOUR, City Clerk of The City of San Diego, California, DO HEREBY CERTIFY the results of the canvass of the Special Landowner Election, held in the City of San Diego Community Facilities District No. 1 on Tuesday, January 8, 1991 to be as follows, to wit:

- (a) The whole number of votes cast in the District was 1,195;
- (b) The measure voted upon, and the number of votes given for and against such measure are as follows, to wit:

PROPOSITION A

CITY OF SAN DIEGO, COMMUNITY FACILITIES DISTRICT NO. 1 (MIRAMAR RANCH NORTH), AUTHORIZATION TO INCUR BONDED INDEBTEDNESS AND AUTHORIZATION FOR SPECIAL TAX LEVY

Shall Community Facilities District No. 1 (Miramar Ranch North) City of San Diego, be authorized to 1) incur a bonded indebtedness in an amount estimated to be \$73,000,000, subject to inflation, to finance the installation of major street improvements, as well as sewer, water and drainage improvements, and other public facilities, including parks, library, fire station and recreational buildings, together with appurtenances, 2) to levy special taxes to pay for said facilities and/or any authorized and issued bond indebtedness, and 3) establish an Article XIIIIB appropriations limit equal to the maximum authorized special taxes which may be levied in any fiscal year?

This proposition requires a two-thirds vote.

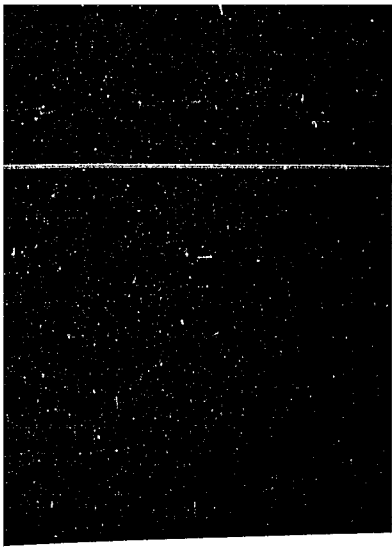
